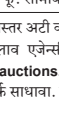

Century-old boat emerges



A steam tugboat dating from the early 1900s has emerged from Serbia's Sava River as Europe's waterways shrink amid extreme heat and drought. The rusting wreck, once known as the Slovenian, surfaced earlier this month near Sremska Mitrovica, northwest of Belgrade. Locals said parts had appeared before, but never so extensively. Historian Andrija Popovic said the boat was built in Budapest in 1913 and later transferred to the Kingdom of Serbs, Croats and Slovenians after World War I. It struck a German mine in April 1945 while carrying wounded fighters and equipment.

Glacier melts, bodies found

The bodies of two Belgian mountaineers who went missing in the Alps have been found, officials said. The remains emerged as the Trift glacier melted. DNA tests confirmed they belonged to two Belgian hikers, aged 39 and 41 when they disappeared near Weissmies mountain in 1992. Such discoveries are increasingly common as glaciers retreat rapidly across Switzerland.

Turkish arms ship hijacked

Pirates hijacked a Cameroon-flagged cargo ship carrying Turkish weapons off Somalia's Puntland coast, an official said. The M/V LUTUF, seized on Monday, was carrying weapons for a Turkish military training facility in Mogadishu. Its 10-member crew included six Indians. The status of the crew and cargo remained unclear.

North Korea fires missile barrage

Seoul: North Korea launched a barrage of ballistic missiles towards the sea on Thursday, a day after it shrugged off a US decision to scale back military drills with South in an apparent bid to resume diplomacy. South Korea's Joint Chiefs of Staff said about 10 short-range ballistic missiles were launched from the North's capital region around 5pm. The missiles flew about 300km towards its eastern waters. South Korea said it had bolstered surveillance and was closely coordinating with the US and Japan.

Central African Republic gold mine collapse kills over 100

Bangui: More than 100 people were killed after an artisanal gold mine collapsed in Zambouye in the Central African Republic on Tuesday, with rescuers continuing to recover bodies on Thursday. Several underground tunnels collapsed, triggering a landslide, a court said. Red Cross volunteer Gervais Ganagoro said more than 10 bodies were recovered on Thursday morning alone, while the number of people still buried remained unclear. An investigation has been opened into the collapse and possible criminal liability. Artisanal mine accidents are common in the country, where miners often work in poorly reinforced pits with little protection.

Indian dies in Israel, one held

Jerusalem: An Indian national has died in Israel and a suspect has been arrested, the Indian Embassy in Tel Aviv said. The embassy identified the deceased as Rajiv Acharya and said Israeli authorities were investigating the circumstances surrounding his death. "The embassy is in close contact with the Israeli authorities," it said. The mission expressed condolences to Acharya's family and said it was ready to provide all possible assistance. It will continue to monitor the case and remain in contact with the authorities. —PTI

Mails reveal Iran deportation link

Los Angeles: US immigration officials worked with Iran to deport Iranians in 2025, newly released emails show, revealing cooperation between the two governments despite mounting tensions. Hundreds of emails obtained by the National Iranian American Council and made public on Tuesday detail how the countries arranged three flights that deported over 100 Iranians in September and December 2025 and January 2026. The emails show Iranian officials had some influence over who was sent back, with US Immigration and Customs Enforcement (ICE) officials apparently accepting last-minute changes requested by Iran. "Per request from the Iran Embassy I added a few cases," an unnamed ICE official wrote in late August, a month before the first flight. Just over a week later, an official with the same job title sought another change after meeting the "Director at the Iranian Embassy," Iran has requested that I amend the

US NATIONAL DEBT TOPS \$40TN

US national debt has more than doubled in a decade to reach a milestone \$40 trillion, Treasury figures show. The rise reflects years of heavy spending under both the Trump and Biden administrations, along with higher interest payments that have steadily added to the total. In 2016, the national debt stood at just under \$20 trillion. The Congressional Budget Office had projected overall borrowing would reach \$39.6 trillion by the end of fiscal year 2026. The CBO said the US was nearing its \$41.1 trillion debt ceiling, with debt projected to climb to about \$64 trillion by 2036. As the federal government spends more to cover its budget deficits, consumers have faced higher interest rates and inflation.

previous manifest and expedite the removal process," the official wrote. The coordination remained a priority even as ICE officials acknowledged Iranians were fleeing their country during the deadly 12-day war with the US and Israel in June 2025. Emails suggest pressure to carry out the deportations came from the highest levels of the Trump administration. Then acting ICE director Todd Lyons described repatriating Iranian immigrants as a "priority" shortly after President Donald Trump warned on June 16 "Everyone should immediately evacuate Tehran!" Another official urged colleagues to "identify a solution for this White House priority". The emails also show ICE officials arranging meetings between Iranian officials and people detained in the US. Eleven Iranians have alleged in an unrelated lawsuit that they were forced to meet Iranian government officials while in ICE detention. The Department of Homeland Security has denied allegations that ICE shared asylum application records with Iran. —AP

Russian missile, drone blitz claims 16 lives in Kyiv region

Hours-long aerial assault pounds Ukrainian capital as air defences face intense strain; 40 people injured

Kyiv: Russia pounded Kyiv and the surrounding region with scores of missiles and drones in a nighttime attack that killed at least 16 people, officials said on Thursday.

The barrage included ballistic and cruise missiles and fast-flying, jet-powered drones, putting further strain on Ukraine's air defences. Explosions boomed across the capital as the attack continued for hours.

Emergency services said 15 people were killed in Kyiv and another in the wider Kyiv region. About 40 people were wounded, Ukrainian President Volodymyr Zelenskyy said. "It was a massive attack," Zelenskyy said, adding that Russia had combined different types of missiles and drones to cause maximum damage to civilian



infrastructure. The Russian Defence Ministry said the strikes hit a Kyiv industrial site manufacturing components for Ukraine's Flamingo cruise missiles. It also claimed sites involved in drone production and storage, an ammunition depot and a logistics centre were hit. —AP

Israel builds gallows for 'Gazan' terror convicts

Facility to have death row wing, viewing areas for victims' families

Israel is building a gallows to execute Palestinians convicted of terrorism under a law passed by the Knesset in March. National Security Minister Itamar Ben-Gvir unveiled the site this week, saying the facility would include a death row wing, gallows and viewing areas for victims' families. "We are making history," Ben-Gvir said. "Terrorists deserve only one thing: death by hanging." The law mandates hanging for terrorism-related killings and applies only to Palestinians as it is enforced through military courts that do not try Israeli citizens. Legal experts and human rights groups have called it a

two-tier justice system. The law faces a challenge in Israel's Supreme Court over violations of rights to life, dignity, equality and due process.

Ben-Gvir said the facility fulfilled a campaign promise ahead of national elections scheduled for Oct 27. Over 9,300 Palestinians are held in Israeli prisons, according to Israeli rights group HaMoked.

Mossad chief discusses Turkish presence in Syria

Mossad chief Roman Gofman spoke with Syrian Foreign Minister Asaad Hassan al-Shibani about Turkey's military presence in Syria amid growing Israel-Turkey tensions, Kan TV reported.

Pak govt refiles plea on Imran hospital shift

Islamabad/Lahore: The Pakistan government on Thursday refiled a review petition in the Supreme Court, seeking modification of its order to shift jailed former premier Imran Khan to a private hospital for treatment.

The court had directed that the 73-year-old Pakistan Tehreek-e-Insaf founder be taken to Shifa International Hospital in Islamabad by Thursday midnight. The government had initially agreed to implement the order, but later sought its review. Khan's party has threatened contempt proceedings. —PTI

Dhaka: Bangladesh PM Tarique Rahman's proposed visit to India next month for the Brics Summit remains unlikely unless an environment based on mutual trust is created and New Delhi extends a "dignified invitation", Foreign Affairs Adviser Humaitun Kobir has said.

Kobir said Dhaka was in no hurry to arrange a top-level visit without clearly defined national interests.

"There is no justification for rushing into a top-level visit by going beyond the national interest," Kobir told state-run BSS news agency in an interview published on Thursday. The comments came amid uncertainty over Rahman's proposed visit to Delhi for the Brics Summit on Sept 12-13 and strains in bilateral ties over Dhaka's demand for the extradition of Sheikh Hasina.
