# PM in Maldives ties reset

Meets leaders from across political spectrum

India-Maldives Parliamentary Friendship Group

Celebrates 60 years of diplomatic ties

Participates in Independence Day celebrations

Prime Minister Modi sought to drive home the message of unity and friendship as he met with political leaders from different parties in the Maldives. The PM who is on a two-day state visit to the island nation, arrived on Friday in Male where he met and held talks with his Maldivian counterpart, President Mohamed Muizzu.

Post the talks, the two leaders announced that four MoUs and three agreements had been inked, India had extended a Line of Credit (LoC) worth Rs 4,850 crore to Maldives, and discussions towards an FTA had begun.

"Had a meaningful meeting

with members of different political parties of the Maldives. The participation of leaders across the political spectrum underscores the bipartisan support for the strong and time-tested India-Maldives friendship. Our shared values continue to guide this important partnership," the PM wrote on X. The PM's visit comes at a special time, as this is the year in which India and Maldives celebrate 60 years of diplomatic relations. His visit also coincides with the Maldives' Independence Day celebrations for which he had been invited as a special guest.

Marking the occasion External Affairs Minister S Jaishankar, who had accompanied the prime minister to Male, wrote, "Honoured to join PM @nar-

endramodi for the Independence Day celebrations in Malé today. We celebrate 60 years of diplomatic relations as well, reiterating our commitment to further strengthen our partnership for peace, prosperity and stability in the Indian Ocean Region."

The minister's mention of the Indian Ocean region will not go unnoticed. Eyebrows were raised when President Muizzu broke with tradition and visited Ankara and Beijing in his first state visit shortly after taking power in January last year. Given that New Delhi had normally been the first port of call for any Maldivian president till then, concerns rose that President Muizzu may be adopting an anti-India stance.

## Kanwar Yatra political trump card for Yogi

The Kanwar Yatra, once a humble pilgrimage to Lord Shiva, has morphed into a stage for political theatrics, identity assertion, and social engineering — and every party now wants a share of its spiritual glow.

The recent controversy in Bareilly, where a schoolteacher advised students to "light the lamp of knowledge instead of fetching Kanwar," exploded into a political flashpoint. Right-wing groups accused him of "insulting Hindu beliefs," leading to an FIR. The teacher insisted he meant no disrespect, saying, "I wanted to inspire students towards education. I respect the Yatra, but knowledge too is sacred."

But nuance has little space when faith and politics collide. As lakhs of saffron-clad devotees walk barefoot carrying Ganga water for Lord Shiva, the Kanwar Yatra has trans-

formed into a political carnival. "Faith is no longer just personal in India — it's political currency," said political analyst Rajendra Kumar. "And the Kanwar Yatra has become one of the biggest tools to tap into that."

Since 2017, Chief Minister Yogi Adityanath has elevated the Yatra into a state-sponsored spectacle. Drones shower petals, loudspeakers blare bhajans and pro-BJP slogans, and authorities issue directives that critics say subtly target Muslims — such as publicising ea-

tery owner names or pushing "Sanatani" (vegetarian) stickers on shops.

"This is not about food. It is about preserving culture," said Mahesh Vats, a VHP volunteer in Meerut. But Muslim vendors like Mohammad Aslam see it differently: "People avoid our stalls after seeing our names. It is an indirect boycott."

"Walking for Mahadev makes me feel equal. I forget my caste," said Ravi Kumar, a 22-year-old Dalit labourer from Etah on his first Yatra.

## Nitish hikes pension for retd journo

Ahead of the assembly election, Bihar chief minister Nitish Kumar on Saturday announced an enhancement in the pension of retired journalists under the 'Bihar Patrakar Samman' scheme from Rs 6,000 per month to Rs 15,000 per month. Now, all eligible retired journalists, registered with the Bihar government, will now get the enhanced pension. Announcing this decision, the CM, in a post on X on Saturday, wrote, "I am pleased to inform you that under the 'Bihar Patrakar Samman' pension scheme, instructions have been given to provide a monthly pension of Rs 15,000 instead of Rs 6,000 to all eligible journalists."

Additionally, in the event of the death of a journalist receiving pension under the scheme, instructions have been given to provide their dependent/spouse with a lifetime monthly pension of Rs 10,000 instead of the earlier amount of Rs 3,000, he wrote.

## AI pays interim relief to kin of victims

Air India on Saturday said it has released the interim compensation of Rs 25 lakh to the families of 168 victims — 147 passengers and 19 people on the ground — so far, and the requisite documents of 52 others have been verified.

Air India flight AI 171, operated with Boeing 787-8, en route to London Gatwick, crashed soon after takeoff from Ahmedabad on June 12, killing 241 of the 242 passengers on-board and another 19 on the ground. All victims were identified, and their bodies were handed over to the families for the last rites.

In a statement, Air India said, "Over a month ago, Air India started releasing interim payment of Rs 25 lakh to the affected families, to help them meet their immediate financial needs. The interim payment will be adjusted against any final compensation."

"Air India has, so far, released

the interim compensation to the families of 147 of the 229 deceased passengers and also the 19 who lost their lives at the accident site. In addition, the requisite documents of 52 others have been verified, to whose families the interim compensation will be released progressively."

Meanwhile, the Tata Group has also registered 'The AI-171 Memorial and Welfare Trust', dedicated to the victims of the tragic accident, which has pledged an ex gratia payment of Rs 1 crore to the family of the deceased victims. It has also assured support for rebuilding the B.J. Medical College Hostel infrastructure, where the plane crashed into seconds after take-off. "The Trust will also provide aid and assistance for alleviation of any trauma or distress suffered by the first responders, medical and disaster relief professionals, social workers, and governmental staff who provided invaluable institutional support and service in the aftermath of the accident," said Air India in its statement.
