FIGHT AGAINST COVID FINE EXAMPLE OF COOPERATIVE FEDERALISM: MODI



Prime Minister Narendra Modi on Tuesday called for focus on both life and livelihood by boosting the health infrastructure with emphasis on more testing and tracing of coronavirus cases and at the same time increase the economic activities, keeping in view both current needs and future requirements.

In his video talks with the chief ministers and administrators of 21 states and UTs in the sixth round of discussions, he laid stress on continuously keep driving the fact danger of the virus is not over yet and the need to remain vigilant while opening up the economy. Home Minister Amit Shah, who also joined the talks, said though India so far fought a successful battle against the pandemic, the road to recovery ahead is long and suggestions given by the PM on use of mask/face cover, maintaining 2 yards distance should be followed by all.

The PM steered clear of any further lockout, stressing the last two weeks of Unlock 1.0 gave "a big lesson if we keep following the rules, keeping all the guidelines, then Corona crisis will cause least harm to India."

"By now almost all the offices have been opened, even in the private sector, people have started going to office, in the markets, the streets are getting crowded, then all these measures will help to prevent the corona



from spreading fast. The slightest carelessness, laxity, lack of discipline will weaken all of our fight against Corona," he warned.

He said: "We always have to keep in mind that the more we can stop Corona, the more it will stop growing, the more our economy will open, our offices will open, markets will open, transport will open, and so will new employment opportunities."

The PMO press release is silent on what the chief ministers said except that they gave the PM feedback on existing health infrastructure in their states and efforts for augmentation to tackle the impact of the virus as also the awareness campaigns run by them, help provided to the migrant workers in returning home and kickstarting the economic activities in

the states. The states chosen by the PM in the first round of discussions were those that had the least cases of the coronavirus — just 19,144 and less than 150 deaths, reserving the second round on Wednesday for 15 states that have high incidence of the infection crossing 3 lakh and which include Delhi, Maharashtra, Gujarat, Rajasthan, Tamil Nadu, West Bengal, Madhya Karnataka, Pradesh, Andhra Pradesh, Haryana and J&K.

The PM noted of the total cases, two-thirds are in five states, with an overwhelming proportion of cases in big cities, and they form the group with which he would be interacting on Wednesday.

He was happy to inform the low-intensity infection states, "we have tried to save each and every life as the recovery rate in the country is now over 50% and India is among the countries with the least deaths due to the dreaded virus." He gave credit to the timely decisions taken to combat the pandemic to contain its spread in the country. "When we look back, people will remember we have presented an example for cooperative federalism to the world," he said and stressed for the safety of self, family and community, no one should even think about venturing outside house without mask or face cover.

The PM was also happy to underline that due to recent efforts, several green shoots in the economy are now visible which are encouraging to forge ahead like rise in power consumption which was earlier falling, fertiliser sale in May this year seeing a significant increase, a healthy increase in Kharif sowing in comparison to last year, production of two wheelers increasing, digital payment in retail reaching pre lockdown level, increase in toll collection in May and bouncing back of exports.

He mentioned the importance of working together on value chains to give a fillip to trade and industry. Specific economic activity points in the states should work 24 hours a day and loading and unloading should be quickened to give further boost to economic activity, he said.

RAHUL: MORTALITY RATE EXPOSES GUJARAT MODEL

The Supreme Court on Tuesday issued notices to the Centre and the Insurance Regulatory Development Authority (IRDA) on the insurance companies refusing coverage of the mental illness.

A bench of Justices Rohinton Fali Nariman, Navin Sinha and BR Gavai admitted for hearing a petition by lawyer Gaurav Kumar Bansal, appearing as the petitioner-in-person, seeking a direction to IRDA to implement provisions of Mental Healthcare Act-2017 in letter and spirit and submit an action taken report.

The lawyer told the court Section 21(4) of the Act provides for inclusion of mental illness in insurance policies, but it is not complied with till date because of the red tape attitude of IRDA as its failure in not regulating the insurance companies in this regard is creating a lot of hardship to the mentally ill persons. "The bias of IRDA is in itself discrimination against persons with mental illness and as such is causing immense hardship for persons with mental illness. Instead of levying punishment on Insurers for not including the

provision of the Mental Health Care Act, 2017, IRDA is bypassing its responsibilities," Bansal said.

"That one of the Right which Mental Healthcare Act 2017 provides is that the insurer is directed to not to discriminate with Person with Mental Illness (PMI) only on the basis of mental illness and as such is further mandated by Parliament to treat Persons with mental illness alike other diseases as far as medical insurance is concerned," the plea said.

Bansal said to check out the end result of a circular issued by IRDA on August 16, 2018 to implement the Act, he had filed a plea on January 10, 2019 under section 6 of RTI Act 2005 and he was informed in the reply to date none of the insurers implemented its order and despite this, the regulator did not taken any action against any of the insurers.

The plea said, "Despite the fact one year has passed, situation as far as implementation of Section 21 (4) of MHCA 2017 remains the same and what surprised the petitioner is instead of regulating insurance companies, IRDA is acting more like a facilitator for Insurers."

SC no to curbs on FIR against journalists

The SC on Tuesday refused to put any restrictions on registration of the FIRs and criminal cases against the journalists and told Mumbaibased lawyer Ghanshyam Upadhyay to better give a representation before the Centre.

It was hearing a plea no FIR should be lodged against journalists for publishing or telecasting news unless sanction has been granted by the Press Council of India (PCI) constituted under an Act of Parliament or any other judicial authority.

A Bench of CJI Sharad Arvind Bobde and Justices MR Shah and AS Bopanna heard Upadhyay through video-conferencing on how some TV news channels are targeted with a score of FIRs filed in different states to snub their voice and to prevent them from awakening the citizens from nefarious and dangerous activities of "anti-social and anti-national persons."

The BJP on Tuesday carted off its MLAs to a hotel in Jaipur for a 3-day Prakshikshan Shivir (training camp). The legislators of the saffron party gathered at the state BJP office in the morning for a meeting and from there left for a luxury hotel on the Jaipur-Tonk Highway in buses and cars.

Of the 72 BJP MLAs, 8 including former CM Vasundhara Raje, were not present. They were expected to join later. BJP has the support of 4 MLAs of Rashtriya Loktantrik Party (RLP). Senior leaders P Murlidhar Rao and V Satish were also present at the legislator body meet.

State BJP chief Satish Poonia came down heavily on the Congress, and said,

"300 persons have died in the state and the government is busy enjoying musical evenings, the public is watching. The CM talks of horse trading we have seen elephant trading in this and previous headed by Ashok Gehlot." Poonia was referring to the merger of all six BSP MLAs into Congress through Ashok Gehlot in his second and current (third) tenure as the CM. Poonia said, "Congress is a brand when it comes to horse trading. It had tried to destabilise the Bhairon Singh Shekhawat govt. We have no apprehensions of cross voting. We are not scared as we have nothing to lose." However at the same time he added both parties have a history of being en-

gaged in horse trading.

"The Indian troops have broken their promises and again crossed the Line of Actual Control in the Galwan Valley region on Monday evening and purposely launched provocative attacks, leading to severe clashes and casualties", Zhang alleged. "India should stop all provocative actions, meet the Chinese side halfway and come back to the right path of solving disputes through talks," Zhang said.

The Ministry of External Affairs said in New Delhi that the violent face-off was the result of an attempt by the Chinese side to unilaterally change the status quo in the region.

"Given its responsible ap-

proach to border management, India is very clear that all its activities are always within the Indian side of the LAC. We expect the same of the Chinese side," MEA Spokesperson Anurag Srivastava said in response to media queries on the situation in the western sector of the India-China border.

"We remain firmly convinced of the need for the maintenance of peace and tranquillity in the border areas and the resolution of differences through dialogue," Srivastava said, adding that the casualties could have been avoided if the Chinese side scrupulously followed the agreement arrived at earlier at the higher level.

"At the same time, we are also strongly committed to ensuring India's sovereignty and territorial integrity," he added.

NEW DELHI: "India and China have been dis

cussing through military and diplomatic channels the de-escalation of the situation in the border area in Eastern Ladakh. Senior Commanders had a productive meeting on 6th June 2020 and agreed on a process for such de-escalation. Subsequently, ground commanders had a series of meetings to implement the consensus reached at a higher level. While it was our expectation that this would unfold smoothly, the Chinese side departed from the consensus to respect the Line of Actual Control (LAC) in the Galwan Valley. On the late-evening and night of 15th June, 2020 a violent face-off happened as a result of an attempt by the Chinese side to unilaterally change the status quo there. Both sides suffered casualties that could have been avoided had the agreement at the higher level been scrupulously followed by the Chinese side. Given its responsible approach to border management, India is very clear that all its activities are always within the Indian side of the LAC. We expect the same of the Chinese side. We remain firmly convinced of the need for the maintenance of peace and tranquillity in the border areas and the resolution of differences through dialogue. Highest 380 Covid deaths in a day

India on Tuesday recorded the highest 380 COVID-19 deaths in a single day while a record 10,216 patients were cured and discharged from the hospitals in the past 24 hours, raising the recovery rate to 52.47% of 3.43 lakh so far tested positive as against the fatality rising slightly to 2.88%. The cumulative total deaths in the country jumped to 9,900 while only 72 more patients were hospitalised in the past 24 hours, raising the total number of patients still under treatment to 1,53,178. They are, however, less than 1,80,013 discharged so far.

Delhi Health Minister to be tested again

elhi Health Minister Satyendar Jain, who was admitted to a hospital here on Tuesday due to high-grade fever, will be tested again for COVID-19 on Wednesday, a senior official said. The 55-yearold minister was brought to the Rajiv Gandhi Super Speciality Hospital (RGSSH) past midnight and was administered a test for novel coronavirus on Tuesday morning. "He still has fever. The minister tested negative for COVID-19 today. We are going to repeat the test tomorrow after 24 hours of the first test," the senior official said

Taj Mansingh is extended COVID facility

The Delhi government on Tuesday issued an order attaching the Taj Mansingh Hotel to the Sir Ganga Ram Hospital and directed that its premises, including all its rooms, be used as a COVID-19 facility. The move to attach it with the Sir Ganga Ram Hospital (SGRH), comes in pursuance of meeting a projected requirement of 1.5 lakh beds in healthcare facilities in Delhi by July-end, amid a massive surge in coronavirus cases in the national capital.

More corona beds no solution: Ex-AIIMS chief

cormer director of the Delhi AIIMS laughs at the political leaders' craze for creating more beds for the coronavirus patients to tackle current shortage and heavy demand if the virus spreads further, without realising there are not enough doctors and other healthcare staff to manage them. Dr Mahesh Chandra Misra (68), who retired in January 2017 after serving the AIIMS for 37 years, says the manpower shortage is already affecting treatment of those hospitalised after getting infected. No use creating the infrastructure without the manpower to run it, he stressed.

"COVID-19 situation in the country is getting only worse. It is not getting any better," observed Justice Rohinton Fali Nariman heading the Bench with Justices Navin Sinha and B R Gavai. It does not make any sense to keep the jails overcrowded when some of the accused could be granted either bail or parole or have already been granted such reliefs and are out now. —Our Bureau


