स्वतंत्र होंगे जेल से 360 कैदी

भोपाल, (निप्र)। मध्य प्रदेश की अलग अलग जेलों में आजीवन सजा काट करे 360 कैदियों को 15 अगस्त के दिन रिहा किया जाएगा। यह जानकारी गृहमंत्री नरोत्तम मिश्रा ने दी। उन्होंने बताया कि इसमें गंभीर अपराध का कोई कैदी शामिल नहीं है।

गृहमंत्री नरोत्तम मिश्रा ने बताया कि स्वतंत्रता दिवस के दिन मध्य प्रदेश में आजीवन सजा काट रहे 360 कैदी रिहा होंगे। उन्होंने बताया कि इसमें आजादी के अमृत महोत्सव के तहत केंद्र सरकार के गृहमंत्रालय की गाइडलाइन के अनुसार 151 और मध्य प्रदेश सरकार की तरफ से 251 कैदियों की सजा माफ करने का निर्णय लिया गया है। मिश्रा ने कहा कि इसमें गंभीर अपराध का कोई भी कैदी शामिल नहीं है। मंत्री ने बताया कि राज्यपाल ने कैदियों की सजा माफी का अनुमोदन कर दिया है। बता दें देश भर में आजादी का 75वां वर्ष अमृत महोत्सव के रूप में मनाया जा रहा है। इस महोत्सव में जनता से बढ़ चढ़ कर हिस्सा लेने की अपील की गई है। इस बीच गृहमंत्री नरोत्तम मिश्रा ने कैदियों की रिहाई की जानकारी दी है।

आतंकियों की गिरफ्तारी पर बोले गृहमंत्री मार्च से राडार पर थे दोनों संदिग्ध



भोपाल, (निप्र)। राजधानी भोपाल से राष्ट्रीय जांच एजेंसी एनआईए द्वारा दो संदिग्ध आतंकवादियों की गिरफ्तारी के बाद गृह मंत्री डॉ.नरोत्तम मिश्रा ने मंगलवार को कहा कि दोनों संदिग्ध मार्च से राडार पर थे और दोनों के खिलाफ तथ्य और सबूत प्राप्त हुए हैं। डॉ.मिश्रा ने संवाददाताओं से चर्चा के दौरान बताया कि भोपाल से दो संदिग्ध आतंकवादी पकड़े गए हैं। इसके पहले मार्च में जो आतंकवादी पकड़े गए थे। उसके बाद से ये दोनों भी राडार पर थे। दोनों के पास से कई संदिग्ध सामग्रियां पाई गई हैं। जिसके चलते दोनों को गिरफ्तार किया गया है। दोनों के खिलाफ तथ्य और सबूत मिले हैं। गृह मंत्री नरोत्तम मिश्रा ने मंगलवार को कहा कि राष्ट्रीय अन्वेषण अभिकरण ने प्रदेश की राजधानी भोपाल से प्रतिबंधित आतंकी संगठन उल.मुजाहिदीन बालादेश के दो संदिग्ध आतंकियों को गिरफ्तार किया है। मिश्रा ने यहां संवाददाताओं को बताया एनआईए ने भोपाल से जेएमबी के दो संदिग्ध आतंकियों हमीदुल्ला हुसैन उर्फ राजा गाजी और मोहम्मद शहादत हुसैन को रविवार को गिरफ्तार किया। दोनों आतंकी मार्च से तब से ही पुलिस के राडार पर थे। जब जेएमबी के छह संदिग्ध सदस्य भोपाल से गिरफ्तार किये गये थे। उन्होंने कहा कि दोनों संदिग्ध आतंकियों के पास से आपत्तिजनक सामग्री मिली है। मिश्रा ने बताया कि पुलिस और प्रदेश की अन्य एजेंसियों का केंद्रीय एजेंसियों के साथ बढ़िया समजस्य है। दोनों आरोपियों को भोपाल के ईटखेड़ी इलाके से सात अगस्त को गिरफ्तार किया है। उनके मुताबिक बालादेश के इन दोनों नागरिकों को मार्च में भोपाल से गिरफ्तार किये गये जेएमबी के छह सक्रिय सदस्यों से संबंधित मामले में पकड़ा गया है। उन्होंने कहा कि मध्य प्रदेश पुलिस ने 13 मार्च को भोपाल से आतंकी संगठन जेएमबी के चार संदिग्ध सदस्यों को गिरफ्तार किया था और इसके अगले दिन 14 मार्च को भोपाल से ही जेएमबी के दो अन्य सक्रिय सदस्यों को गिरफ्तार किया था।

ALERT SOUNDED: UP TO 20 CM RAIN ON THE CARDS IN 21 DIST

Lightning likely in various divisions

As many as 21 districts are likely to experience very heavy rains ranging from 15 cm to 20cm in the next 24 hours in the state. Orange alert for heavy to very heavy rain has been issued in Madhya Pradesh. Districts like Narmadapuram, Harda, Betul, Chhindwara, Mandla, Seoni, Balaghat, Khandwa, Khargone, Barwani, Alirajpur, Jabua, Dhar may record heavy to very heavy rain up to 20 cm in next 24 hours, according to meteorological department report.

Shahdol, Anuppur, Umaria, Katni, Damoh, Sagar, Bhopal, Raisen, Sehore districts are likely to experience rainfall up to 15cm in the next 24 hours. Besides, lightning may also strike in divisions like Bhopal, Narmadapuram, Indore, Rewa, Shahdol, Jabalpur and Ujjain. In the last 24 hours, Piparia recorded 10cm rainfall while Jhiranya and Goharganj recorded 9cm rainfall. Shahpur recorded 8cm rainfall while Amla, Lakhnadun, Amarwara recorded 7cm rainfall. Ater and Chhapra recorded 6cm rainfall in the last 24 hours. According to the meteorological department, well marked low-pressure area is over coastal areas of Odisha and adjoining parts of northwest Bay of Bengal.

Lightning claims 15 cattle in Betul

Road connectivity between Bhopal and Nagpur has been disrupted following opening of gates of Tawa dam after Narmadapuram region witnessed heavy rains. Many parts of the state are experiencing heavy rainfall, Betul and Narmadapuram are among the worst affected. Devotees stuck in the fast-flowing Pahari river were rescued by villagers in Betul. A vehicle of picnickers was swept away in the flooded Mandhu river in the district. As many as 15 cattle including 2 bulls and 13 goats died due to lightning in

Betul district. Two bulls died due to lightning in Saikheda area and 13 goats died due to lightning in Shahpur of Betul District. Lightning struck a timber depot near Sohagpur Dhana joint of Shahpur block in Betul. The devotees, who were visiting Chhota Mahadev Bhopali temple in Betul, had a narrow escape while they were crossing the flooded Pahari river. The devotees got stuck and as strong water current swept them, they caught hold of a fallen tree. The villagers safely rescued them one by one. Roads are submerged in rainwater in Shahpur area. A Tata Sumo jeep was washed away in the Mandhu river in Athner area. No one was in the vehicle when it was swept away in the water current. People from Amravati (Maharashtra) had come for a picnic at the picnic spot located here. They had parked their vehicle on the bank of the river when it was swept in the strong water currents.

CABINET MEETING SLATED TO PASS IMPORTANT BILLS

The next Cabinet meeting is slated to pass some important bills which will be tabled in the upcoming monsoon session of Madhya Pradesh Assembly. Mirchi Baba's proximity to Cong leaders didn't go down well with party

Rape accused self-styled godman Vairagyanand Giri, known as Mirchi baba in religious circles, had access to many top leaders of the Congress while working for the party, that didn't go down well with the party's rank and file. It was last month only when Congress MLA Laxman Singh alerted the party and also state Congress president Kamal Nath advising them to keep away from Mirchi Baba. "Mirchi Baba is campaigning for the party again. We have seen the result of Mirchi yajna during Lok Sabha polls. @INCMP @OfficeOfK-Nath should be alert", tweeted Laxman Singh who is younger brother of former chief minister Digvijaya Singh. Mirchi Yajna mentioned by Singh was in ref-

erence to the Yajna Mirchi Baba performed with 5 tonnes of red chilli for victory of Digvijaya Singh during 2019 Lok Sabha polls. Singh lost to BJP nominee Pragya Thakur with a huge margin of votes. Mirchi Baba had claimed that if Digvijaya Singh didn't win he would undertake a Jal Samadhi but after the polls he was untraceable for some time. He later submitted an application to Bhopal collector that he be permitted to undertake Jal Samadhi at upper lake. Of course, he was not to get such permission. It's not the first time when Laxman Singh warned the party against Mirchi Baba but the latter continued to call the shots in the party ostensibly with free hand from the state unit president despite the fact his statements many a time advocated violence and stoked controversies, said party leaders. In July, he said those who would behead the

maker of film Kali would get a reward of Rs 20 lakh from him. Earlier, he said, those who beheaded Kanhaiya should be shot dead publicly. Coming from a village in Bhand district Mirchi Baba flaunted his proximity with Congress leaders through photographs posted on social media including Facebook, Twitter and Instagram. On July 23, he said he had a meeting with saints in Gwalior-Chambal region and as many as 10000 sadhus and saints would campaign for the Congress for the coming elections. A senior party leader said, "His rise in the party was embarrassing for us but we were helpless as he was patronized by top leaders despite his controversial backgrounds." State Congress spokesperson JP Dhanopia said, "We have no comments to offer on the accusation of rape. It's for law to deal with the case."

The RP has approved these unaudited financial results only to the limited extent of discharging the powers of the Board of Directors of the Company (suspended during CIRP) which has been conferred upon him in terms of provisions of Section 17 of the Code. (2) In accordance with the Code, public announcement was made calling the financial and operational creditors of the Company to submit their claims with IRP / RP. Accordingly, IRP / RP had collated the claims submitted by the creditors and reconciled the same with the accounts. Till the final outcome of CIRP process, no accounting impact in the books of accounts has been made for an excess, short or non-recognition of claims for operational and financial creditors. (3) The carrying value of property plant and equipment and intangible as at 30th June 2022 is Rs. 13,937.09 lacs and 5.85 lacs respectively. As explained in note 1 above, the Company is under CIRP and accordingly resolution plans were invited from potential resolution applicants. Committee of Creditors ("CoC") has approved one of the resolution plans and the same has been submitted to NCLT for approval. The CIRP is not yet concluded and hence, the final outcome is not known. The Company has not taken in consideration any impact on the value of the asset, if any, in preparation of Financial Results as required by IND AS 10 on "Event after the Reporting Period". The Company has not made assessment of impairment as required by IND AS 36 on Impairment of Assets, if any as at 30th June, 2022 in the value of property plant and equipment and intangible assets. (4) The Company has not been able to obtain confirmations from various debtors, loans and advances from, trade and other payables. Accordingly, adjustments if any arising out of reconciliation with these parties is not readily available. The Company has carried out its internal assessment and accordingly provided 'written off' back certain receivables/payables/loans and advances. (5) During the quarter the company has provided an interest amounting to Rs. 309.65 Lacs as per the sanction letter stipulation, however the bank has not provided the same. Therefore, there exists a difference with regards to aforesaid amount as per balance confirmation provided by the banks and books of accounts. (6) During the quarter the company has accrued interest income on Fixed Deposits with Axis Bank amounting to Rs. 5.65 Lacs, however the bank has not provided the same. Therefore, there exists a difference with regards to aforesaid amount as per balance confirmation provided by the banks and books of accounts. (7) Renewable Energy Certificates of Rs. 1,173.00 Lacs is subject to adjudication of pending litigation at Apex Court of the management is hopeful of realizing the amount considering the legal opinion. (8) During the FY 2021-22, the Company has received order in relation to Service Tax matter from, Principle Commissioner CGST & Central excise vide no. 04-05/COMMR/ST/IND/2021 / 6073 received on 3rd April, 2021 related to Valuation method for calculation of Service tax. Approx demand in order is Rs. 8,798.66 Lacs plus interest. The Service tax department lodged the claim before the RP. The same was rejected by RP. Thereafter, the department filed an appeal in NCLT. NCLT vide order dated 07th October, 2021 has directed the RP to consider the claim of Principle Commissioner CGST & Central excise and admit as per the law. Accordingly, the entire claim of the department has been admitted by the RP and provided in the books of accounts. (9) Figures of the previous periods have been regrouped and reclassified where ever necessary and feasible, in order to make them comparable.
