विदिशा,(निप्र)। विदिशा के नटनर तहसील के गांव आमखेड़ा सूखा में जमीन विवाद का मामला सामने आया है। मंगलवार को गांव के कुछ लोग जनसुनवाई में पहुंचे और पटवारी पर जमीन हड़पने का आरोप लगाया। राजेश प्रजापति और बाकी ग्रामीणों ने बताया कि उनके पास करीब 40 बीघा जमीन है, जिस पर वे पिछले 70-80 सालों से खेती कर रहे हैं। राजस्व रिकॉर्ड में भी जमीन उन्हीं के नाम पर दर्ज है। उनका कहना है कि वे इसी जमीन से खेती करके अपने परिवार का पेट पालते हैं। पटवारी ने बिना बताए जमीन की नपती करवाई ग्रामीणों का आरोप है कि पटवारी ने बिना बताए और बिना उनकी मौजूदगी के जमीन की नपती करवा दी। अब वो जमीन गांव के चौकीदार को दी जा रही है। जबकि चौकीदार के पास पहले से ही आमखेड़ा

फर्जी शादियों से लाखों की ढगी, महिला गिरफ्तार

23 साल की अनुराधा ने 25 युवकों से की फर्जी शादी | शादी के तीसरे दिन नकदी-जेवर लेकर राजस्थान से हुई थी फरार

भोपाल,(निप्र)। भोपाल में फर्जी शादियों के जरिए लोगों से लाखों रूपए की ठगी करने वाली एक महिला को पुलिस ने गिरफ्तार किया है। आरोपी महिला शादी का झंसा देकर पुरुषों से मोटी रकम ऐंठती थी और फिर अचानक गायब हो जाती थी। आरोपी अनुराधा पासवान अब तक करीब 25 लोगों से नकली शादी कर उन्हें ठग चुकी है। 23 साल की अनुराधा पासवान मूल रूप से यूपी के महाराजगंज जिले के कोल्हड़ बाजार की

रहने वाली है। वर्तमान में वो भोपाल में रह रही थी। 3 मई को राजस्थान के मानटाउन निवासी विष्णु शर्मा ने थाने में रिपोर्ट दर्ज करवाई कि उसे खंडवा निवासी सुनीता और पप्पू मीना ने मनपसंद लड़की से शादी करवाने का झंसा देकर भोपाल निवासी अनुराधा का फोटो दिखाया। इसके बाद सवाई माधोपुर कोर्ट में फर्जी एपीमेंट के जरिए 2 लाख रूपए लेकर शादी करा दी। शादी के महज तीन दिन बाद ही अनुराधा घर से कैश, जेवर

और मोबाइल लेकर फरार हो गई। मामले की गंभीरता को देखते हुए राजस्थान पुलिस ने एक विशेष टीम गठित की। टीम ने भोपाल में स्थानीय मुखबिरों की मदद से फर्जी शादी गिरोह से संपर्क किया। टीम के एक सिपाही को अविवाहित बताकर फर्जी शादी कराने की योजना बनाई गई। इसी दौरान एजेंट द्वारा दिखाई गई तस्वीरों में फरार अनुराधा की पहचान हुई। टीम ने भोपाल के कालापिपल स्थित पन्नाखेड़ी गांव में दबिश देकर अनुराधा को गिरफ्तार कर लिया। अनुराधा हाल ही में एक और फर्जी शादी कर वहीं रह रही थी।

Taking a leaf out of the Central government's book, the Cabinet approved the construction of hostels for working women in all industrial hubs to provide them with safe and affordable accommodation.

In the first phase, the state has decided to make an investment of Rs 66 crore in Udyogpuri (Ujjain), Rs 76 crore in Pithampur, Rs 29 crore in Malanpur and Rs 77 crore in Mandideep.

"More funds will be invested in other industrial areas at a later stage," Vijay-vargiya said.

The government is considering financial support from industries through their Corporate Social Responsibility (CSR) funds to aid in the development of these facilities.

In addition to this, a provision of Rs 100 crore has also been made for the skill development scheme. Besides, Rs 321 crore has been allocated to Rewa District Hospital, providing a substantial healthcare boost for the poor and middle-class residents of Central India.

No relief till ...

He said all provisions of the amended law that infringe on fundamental rights must be open to challenge.

Sibal called the 2025 amendments an attempt to "capture waqfs through a process which is non-judicial."

He strongly criticised a provision allowing government officers to determine whether a waqf property encroaches on government land. If such a dispute arises, the property immediately loses its waqf status until the matter is resolved. Sibal also said the new law invalidates the long-standing principle of "once a waqf, always a waqf." Under the amendment, if a waqf property is unregistered, it is no longer recognised as waqf—a major departure from the earlier law, which penalised the manager for non-registration but upheld the waqf's validity.

SC: 3-yr legal ...

The SC observed that the recruitment of "raw graduates" as judicial officers without any training or background of legal practice had not proved to be a successful experiment. The court further noted that from the first day of his/her assuming office, a judge had to decide, among others, questions of life, liberty, property and reputation of the litigants. The court further noted that to induct graduates fresh from the universities to occupy seats of such vital powers was neither prudent nor desirable.

The SC further found that neither knowledge derived from books nor pre-service training could be an adequate substitute for the first-hand experience of the working of the court system and the administration of justice begotten through legal practice. The court found that experience as a lawyer was essential to enable the judge to discharge his/her duties and functions efficiently and with confidence and circumspection. The court, therefore, directed all the states to prescribe a minimum of three years' practice as a lawyer as an essential qualification for appointment as a judicial officer on the lowest rung.

Malhotra's Bangladesh connection emerges

New Delhi: Fresh details have emerged in the ongoing investigation of alleged Pakistani spy and travel YouTuber Jyoti Malhotra, revealing her attempts to build links not just with Pakistan and China, but also with Bangladesh. Central agencies probing the case, in coordination with Haryana Police, have discovered documents suggesting that Malhotra had applied for a Bangladesh visa, raising new questions about the extent of her international network.

Investigators have accessed a visa application form submitted by Jyoti to the Bangladesh High Commission. While the form does not carry a date, officials believe it was filled out recently,

possibly after the April 22 Pahalgam terror attack in Jammu and Kashmir. The timing of the application has raised red flags among agencies, especially since her travel was reportedly being shown as part of her work as a travel blogger, despite alleged deeper motives.

Many reports said that the Haryana YouTuber remained remorseless during the interrogation and insisted that she was being targeted for her free speech.

She has been accused of sharing sensitive military information with Pakistani intelligence operatives, raising concerns about security breaches, particularly in the backdrop of ghastly Pahalgam attacks.
