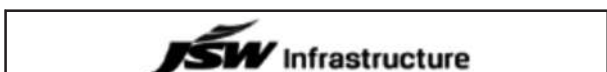

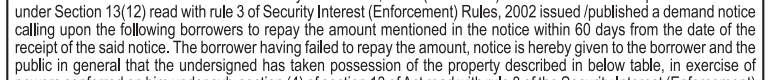

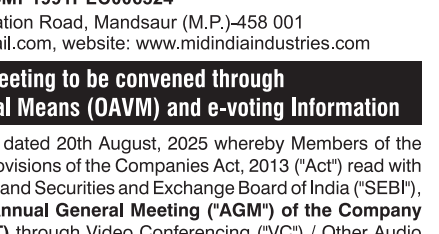

17 killed as floods wreak havoc in Pak's Punjab province

PTI LAHORE At least 17 people have died in the past 24 hours as floods submerged hundreds of villages across Pakistan's Punjab province, officials said on Thursday. Catastrophic flooding in the Sutlej, Ravi, and Chenab rivers has triggered mass evacuations, damaged infrastructure, and inundated millions of acres of agricultural land in the province of over 130 million people. According to Punjab Emergency Services Rescue 1122, as many as 17 people died in the floods in the past 24 hours - seven in Sialkot, four in Gujrat, three in Narowal, two in Hafizabad, and one in

Gujranwala. Officials said the unusually high water levels in the three rivers were caused by heavy rains combined with excess water released from dams by India. Federal Minister for Development Ahsan Iqbal has accused India of "water aggression". "India has resorted to water aggression. This is a natural disaster that can only be dealt with through cooperation on both sides of the border. India should have treated it as a natural calamity and worked together with Pakistan, but instead, it suddenly released water in the form of a flood wave, using it as a weapon," he said.

UNHCR says over 2.3 mn Afghans returned from Iran & Pak this year

Over 2.3 million Afghan refugees have returned to Afghanistan from Iran and Pakistan this year, according to United Nations High Commissioner for Refugees (UNHCR). The UN Refugee agency warned that these Afghan refugees face severe hardship and called for support to meet their basic needs, local media reported.

According to a UNHCR statement issued on Thursday, Afghan refugees are arriving in a nation unprepared to receive them. The UNHCR shared a picture with a message that reads, "The world cannot turn its back on Afghans now."

While calling for international community's help for Afghan refugees, UNHCR in a post on X wrote, "Over 2.3 million Afghans have returned from Iran and Pakistan this year - many under pressure, and to a country unprepared to receive them. We're calling for urgent support to meet their most basic needs. The world cannot look away now."

Humanitarian groups have repeatedly warned that deported Afghans after returning to Afghanistan will face poverty, unemployment, lack of housing and severe restrictions on education and personal freedoms, especially women and girls. Afghanistan-based Khaama Press reported.



UN experts warned that many refugees are being sent to a nation whose rulers face international accusations of systematic human rights violations. Earlier this month, the UNHCR called on Pakistan to halt deportation of vulnerable Afghan refugees, warning that forcible repatriation, particularly of women, girls and people who are ill could violate basic human rights and protections. UNHCR has voiced serious concern over Pakistan's decision to deport Afghan refugees who have temporary residence permits and demanded protection of vulnerable people, leading Afghan news agency Khaama Press reported.

There is no coordinated international support.

B'desh: 432 new dengue cases reported as 2025 count crosses 30k mark

A total of 432 dengue cases have been reported in Bangladesh in the past 24 hours till Thursday morning, bringing the total number of confirmed cases in 2025 to 30,376, local media reported.

No new fatalities linked to dengue were reported during this period with the number of deaths remaining at 118, according to the Directorate General of Health Services (DGHS). According to the DGHS, new cases were reported in Dhaka South City Corporation (90), Barishal Division (86), Chattogram Division (70), Dhaka Division (68), Dhaka North City Corporation (52), United News of Bangladesh (UNB) reported. Currently, 1,426 patients were undergoing treatment in various hospitals of Bangladesh. As many as 575 people lost their lives due to dengue in 2024.

Israeli strikes across Gaza kill at least 11 people

ANI GAZA CITY

Israeli strikes across Gaza killed at least 11 people, including five aid seekers, medical sources said, as reported by Al Jazeera on Thursday.

The latest strikes were conducted in northern Gaza's Jabalia an-Nazla area, as per Al Jazeera.

As of Thursday, Israel launched a mass arrest campaign, arresting 12 people across the West Bank. The arrested people were journalists, reform activists, and freed prisoners amid intense raids and home invasions.

Gaza's Health Ministry has recorded four deaths "due to famine and malnutrition" over the past 24 hours, including two children. This brings the total number of hunger-related deaths in the enclave 317, including 121 children, Al Jazeera reported.

No buildings remain standing in the southern part of the Zeitoun neighbourhood in Gaza City as the Israeli ground operation launched earlier this month demolished more than 1,500 homes, according to Gaza's Civil Defence.

All members of the UN Security Council, except the United States, jointly backed the IPC's declaration that famine in Gaza is a 'man-made crisis' on Wednesday, despite Israel and the US attacking the findings.

US President Donald Trump presided over a policy meeting on Israel's war in Gaza and post-war plans for the Palestinian territory with input from former British Prime Minister Tony Blair and former Trump Middle East envoy Jared Kushner, a senior White House official said.

■ सुप्रीम कोर्ट आदेश पर सीबीआई ने संभाली थी जांच ■ कांग्रेस विधायक के बेटे समेत कई डॉक्टर आरोपी

भोपाल। मध्यप्रदेश के बहुचर्चित व्यापमं फजीवाड़ा मामले में लगभग 10 साल बाद आरोप तय होने जा रहे हैं। यह वही घोटाला है जिसने न केवल राज्य बल्कि देशभर में सुर्खियां बटोरी थीं। फर्जी तरीके से पीएमटी पास कराने और परीक्षा में जालसाजी से जुड़े इस मामले में अब विशेष सीबीआई ट्रायल कोर्ट में सुनवाई शुरू होगी। कुल 122 आरोपी इस केस में शामिल हैं, जिनमें कई डॉक्टर और प्रभावशाली लोगों के नाम भी हैं। इस मामले में सबसे पहले 2013 में झांसी रोड थाना, ग्वालियर में एफआईआर दर्ज की गई थी। इसके बाद 2015 में सुप्रीम कोर्ट ने सीबीआई जांच के आदेश दिए। जांच शुरू होने से पहले यह केस एसआईटी के पास था, लेकिन आदेश के बाद इसे सीबीआई को सौंप



दिया गया। जुलाई 2015 में सीबीआई ने केस दर्ज किया और फिर 5 दिसंबर 2020 को कोर्ट में चालान पेश किया लगभग पांच साल बाद, 3 जुलाई 2025 को सीबीआई मजिस्ट्रेट कोर्ट से केस कम्पट हुआ और 26 जुलाई 2025 को डिस्ट्रिक्ट एंड सेशंस जज ने

भोपाल। मध्यप्रदेश के बहुचर्चित व्यापमं फजीवाड़ा मामले में लगभग 10 साल बाद आरोप तय होने जा रहे हैं। यह वही घोटाला है जिसने न केवल राज्य बल्कि देशभर में सुर्खियां बटोरी थीं। फर्जी तरीके से पीएमटी पास कराने और परीक्षा में जालसाजी से जुड़े इस मामले में अब विशेष सीबीआई ट्रायल कोर्ट में सुनवाई शुरू होगी। कुल 122 आरोपी इस केस में शामिल हैं, जिनमें कई डॉक्टर और प्रभावशाली लोगों के नाम भी हैं। इस मामले में सबसे पहले 2013 में झांसी रोड थाना, ग्वालियर में एफआईआर दर्ज की गई थी। इसके बाद 2015 में सुप्रीम कोर्ट ने सीबीआई जांच के आदेश दिए। जांच शुरू होने से पहले यह केस एसआईटी के पास था, लेकिन आदेश के बाद इसे सीबीआई को सौंप दिया गया। जुलाई 2015 में सीबीआई ने केस दर्ज किया और फिर 5 दिसंबर 2020 को कोर्ट में चालान पेश किया लगभग पांच साल बाद, 3 जुलाई 2025 को सीबीआई मजिस्ट्रेट कोर्ट से केस कम्पट हुआ और 26 जुलाई 2025 को डिस्ट्रिक्ट एंड सेशंस जज ने आदेश देकर इसे विशेष सीबीआई ट्रायल कोर्ट में भेज दिया। अब अदालत में आरोप तय होंगे और सुनवाई शुरू होगी। कई चर्चित नाम फजीवाड़े में शामिल-इस घोटाले में कई ऐसे नाम हैं जिन्होंने हमेशा इस केस को सुर्खियों में बनाए रखा। कांग्रेस विधायक फुदलाल सिंह के बेटे अमितेश कुमार का नाम इसमें शामिल है। निगम अधिकारी डॉ. अतिबल सिंह यादव के बेटे अरुण यादव भी आरोपी बनाए गए हैं। इसके अलावा लखनऊ की डॉक्टर स्वाति सिंह पर आरोप है कि उन्होंने मोनिका यादव के स्थान पर पीएमटी परीक्षा दी। एडवोकेट अभिषेक पाराशर ने बताया कि वह आरोप सीबीआई की जांच और साक्ष्यों में सामने आया था।

भोपाल। राजधानी भोपाल के ईटखेड़ी थाना क्षेत्र में नौ साल की एक मासूम के साथ दरिंदगी का मामला सामने आया। दरिंदगी करने वाला मासूम बच्ची का पड़ोसी है और वह बच्ची दरिंदे को चाचा कहकर बुलाती थी। पुलिस ने आरोपी को गिरफ्तार कर कोर्ट में पेश किया, जहां से उसे जेल भेजा गया है। ईटखेड़ी थाना प्रभारी आशीष संप्रे के अनुसार नौ वर्षीय मासूम अपने माता-पिता के साथ रहती है। दो दिन पहले मासूम बच्ची रात में घर से निकलकर पड़ोस में रहने वाली एक अन्य बच्ची के घर खेलने जा रही थी। बच्ची रास्ते में थी तभी आरोपी उसे मिल गया। आरोपी ने बच्ची से पूछा कि कहाँ जा रही है, तो उसने बताया कि एक सहली के यहां जा रही हूँ। आरोपी ने देखा कि आपसपास कोई व्यक्ति नहीं है तो उसने मासूम को फुसलाते हुए कहा कि तुम मेरे घर चलो, टीवी पर अच्छे कार्टून दिखाऊंगा। मासूम दरिंदे के साथ उसके घर चली गई, क्योंकि वह आरोपी को चाचा बोलती थी। थाना प्रभारी ने बताया कि आरोपी ने अपने घर में ले जाकर एक कमरे में मासूम को बंद कर दिया। उसी कमरे में लगी टीवी तेज आवाज में चालू कर दी, ताकि कोई बाहर आवाज न सुन सके। इसके बाद दरिंदे ने बच्ची से हैवानियत की। मासूम शोर मचाकर रस्ते लगी। आरोपी ने तो पहले मासूम बच्ची को शांत कराने का प्रयास किया, लेकिन जब पीड़िता रोती ही रही तो उसने डर के कारण धमकी देते हुए छोड़ दिया। पीड़िता दौड़ते हुए घर पहुंची और मां को मुहबोले चाचा द्वारा की गई दरिंदगी की आपबीती बताई। इसके बाद परिजन उसके घर पहुंचे तो वह पीछे के दरवाजे से फरार हो गया। आरोपी शादीशुदा है, लेकिन घटना के समय उसका किसी रिश्तेदार के यहां गया हुआ था। पुलिस ने दुष्कर्म और पॉक्सो एक्ट की विभिन्न धाराओं के तहत प्रकरण दर्ज कर आरोपी को गिरफ्तार कर लिया है।
